Supervisor Legg calls the meeting to order at 7:00 PM with the Pledge of Allegiance to the Flag.

#### LANDFILL- Update

Kevin Young of Young & Sommer presents a summary.

K. Young states that the Town of Hunter got a SPDES Permit to discharge leachate; however the discharge must meet strict water quality standards which are very hard to comply with. He adds that an artificial wetland system was put in. He states that under the Clean Water Act, citizen groups can enforce SPDES. He states that a citizen claim was filed from the Riverkeeper as the Town of Hunter had self-reported violations.

He advised the Town Board to enter into an Order on Consent with the State which provides for long term compliance. He adds that NYSDEC has offered such an Order on Consent and he recommends that the Town move forward with this option. This requires the towns' to pay a \$7,000 fine and to conduct a study to bring the Landfill into compliance. He adds that this \$7,000 fine was negotiated down significantly.

Councilman Semenza offers RESOLUTION #1 of 2016 Authorizing the Town Supervisor to Execute Order on Consent. Seconded by Councilman Legg.

The applicant shall show all existing and new right of ways on the final subdivision map along with the approximate location of the septic system and well. S. Killourhy states this is an UNLISTED SEQRA action. The Board reviews the Short EAF submitted and makes a SEQRA Negative Declaration. A public hearing is scheduled for the March 1<sup>st</sup>, 2016 meeting.
