OLD BUSINESS:

<u>1) Haines Falls Auto Site plan:</u> Haines Falls – (J. Michaud Uhrik is recused.) No new submits. MOTION: by S. Killourhy to keep site plan public hearing open until the Nov. 1, 2016 meeting. Discussion: S. Schneider asks why the hearing is to be kept open. S. Killourhy explains for procedural purposes the hearing should stay open until the Board is prepared to complete SEQR. Seconded by A. Dale. Unanimously carried. Public hearing continued to Nov. 1st, 2016 meeting

2) Colandrea 2 lot Subdivision; Final Review: Elka Park- Public hearing held at start of meeting. No one chose to speak. D. Colandrea presents 2 lot subdivision of her 11 acre parcel off Clum Hill Rd and Woodberry Lane. Lot 1 is 8 acres with her existing home and ingress off of Woodberry Lane and lot 2 is 3 acres of buildable land and proposed driveway off of Clum Hill Rd. The SEQR determination of non-significance was decided at the Sept. meeting. The Board acknowledges a few minor corrections need on the final subdivision maps, the spelling of applicants last name and depict where the septic is located at the exiting dwelling. A Board discussion regarding legal deeded ingress/ egress to her existing home if Lot 2 is the only road frontage. J. Vanucchi of Vanucchi Associates states they did not find a deed stating a right – of- way. D. Colandrea states she has a deed that does state legal description of right of way and will have Vanucchi Assoc. redo the maps. Tabled to the November meeting.

3) Morabito 2-lot Subdivision; Preliminary: Haines Falls – A. DiPalermo representing on behalf of his daughter A. Morabito on a proposed 2-lot subdivision of the 3.3 acre parcel. Lot 1 is 0.6 acres with existing home and Lot 2 is 2.7 acre parcel, creating a residential lot. The board acknowledges receiving signed and notarized Boundary Line & RMA by Morabito/DiPalermo for A. DiPalermo legal ingress/egress to his home as the existing driveway will become part of Lot 2. S. Killourhy states this is an UNLISTED action under SEQR. The Board reviews part 1 of the prepared short EAF and completes part 2. The Board grants a negative declaration for the action. The public hearing is scheduled for the November 1st meeting.

<u>4) NYS/ SUNY Mesonet Installation Site Plan:</u> Haines Falls –M. Smith Mathias &K. Donohue from Pyramid Network Services present photos taken from the balloon test on September 20th from 10am – 2:30pm. Members of the public and representatives from the ADK hiking club, Catskill Center and Scenic Cloves Byways organizations raise concerns regarding the size of the tower. More information will be needed and at this time, no public hearing is scheduled.

5) Kursh/Gaffney 4 lot subdivision; Preliminary: Haines Falls – J. Vancucchi of Vanucchi Assoc. presenting the proposed subdivision of the 46.3 acre parcel will create 4 lots giving the 2 buildings their own parcel & creating 2 lots for

open space and public recreational use. The final survey maps show all right of ways and are noted on the plan, demonstrating ingress/ egress to the lands of the Mountain Top Historical Society. S. Killourhy states this is a SEQR Type I action. The Board reviews Part 1 and completes Part 2 & 3 of the Full EAF and grants a negative declaration, determination of non-significance. The Board approves the 4-lot subdivision.

6) Primax Properties 2-lot Subdivision & Dollar General Site Plan: Tannersville- L. Marshall of Mercurio-Norton-Tarolli-Marshall Engineering (MNTM) is presenting. The Board acknowledges the Public hearing held on September 27th, 2016 at the Hunter Elementary School, with 26 people in attendance, including Councilman A. Coiro, D. Kukle and R. Legg. (Thank you for your attendance.) L. Marshall states A. Sellner of Primax properties is researching different types of stone that can be used for the building. S. Killourhy states the Board is at a good place to continue the SEQR determination before going into too much more detail that can be accomplished during the Site Plan review and final subdivision. The Board reviews Part I of the Short EAF for the Subdivision and grants a negative declaration finding a determination of non-significance. The Board reviews Part I of the Full EAF prepared for the Commercial Dollar General Site plan. Due to the late hour, the Board reviews Part 2 of the Full EAF and agrees the applicant will submit a revised Full EAF noting the changes discussed and the Planning Board members will, over the next month complete Part 2 and 3 of the Full EAF to be discussed at the November meeting.
