<u>Eisler 6-lot Subdivision</u> Lanesville / Lexington – chairman S. Killourhy opens the public hearing at 7:06PM. Neighbor N. Ibe wishes to learn more about the subdivision as she has concerns regarding erosion and any potential large development.

APPROVAL OF MINUTES: MOTION: by J. Dixon to approve the minutes of the Regular meeting of November 3rd, 2015 and Public Hearing and Special Meeting for Hunter Mtn Outfitters Nov. 10th, 2015. Seconded by D. Galin. Unanimously carried.

PRIVILEGE OF THE FLOOR – Offered; no comments.

OLD BUSINESS:

1) C. Leach 2 lot Subdivision - Elka Park –S. Demskie of Brooks & Brooks presenting.

Project description: Two (2) lot subdivision of 10.02 acre parcel of land to separate two existing dwellings on to two separate lots. Each lot is 5.01 acres and each dwelling is serviced by an individual well and septic system, and all site improvements existing. The lands being subdivided are on County Rte. 16 or Platte Clove Rd with adequate road frontage. S. Killourhy states this is an UNLISTED action and a SEQR Negative declaration was given at the November meeting. The Board reviews the final subdivision map. MOTION: by C. Knopp to approve 2 –lot subdivision as presented. Seconded by J. Dixon. Unanimously carried.

<u>2) Eisler 6-lot Subdivision</u> Lanesville/Lexington - R. Sardo; Surveyor & P. Eisler; property owner. *Project description:* Six (6) lot subdivision of a 33 acre parcel off Diamond Notch Rd. in Lanesville and lands in the Town of Lexington. Each

parcel will be over 5 acres. Lot 4 has an existing dwelling and garage with its own well and septic. Lots 1, 2, and 3 are beyond where the Town Of Hunter Highway maintains. This is a SEQR UNLISTED action, and a full EAF has been submitted. The Board acknowledges receipt of the new subdivision map.

The Public Hearing was held in accordance with State Town law, notice was in the Windham Journal and adjoining neighbors were notified. Neighbor Nora Ibe expressed concern over any development of the property since there is an issue with steep slopes and erosion issues. Chairman S. Killourhy explains the concern of having grades over 15% and that even though the entire parcel/s are not to be developed the common plan of the development or lots for sale need to be reviewed. It is the obligation of the Board to ensure that the lots for sake are in fact "buildable lots" and therefore must be perked and potential a SWPPP would need to be prepared. The NYC DEP also has concerns regarding steep slopes, construction of the road and did advise that a full SWPPP may need to be done and at the very least NYS DEC SWPPP will need to be submitted. NYC DEP was unable to review the Full EAF and plan at the time of the meeting but will be submitting a letter to the Board and applicant prior to the next meeting. The Board discussed with the applicant other options, making the lots larger and fewer, or hiring an engineer to form a plan for a SWPPP. The application was determined incomplete until the Board receives letters from NYCDEP, NYSDEC and how finds out how the applicant wishes to proceed. It is noted that the Town of Lexington will hold a Public Hearing on Tues. Dec. 8th, 2015.
