PRIVILEGE OF THE FLOOR: Chairman S. Killourhy opens privilege of the floor.

E. Martocci asks the Lead Agency status of the NYS DEC C & D Processing Permit and Transfer Station for Haines Falls Auto. S. Killourhy states the application is still being processed and that the Town did not receive word that DEC was not the Lead Agency or that any dispute for Lead Agency had been filed. The DEC has kept the town as an involved agency during the SEQRA process even though we cannot act.

M. Nihan requests clarification as to why the Town does not want Lead Agency. S. Killourhy responds that typically the Planning Board does want to be Lead Agency for SEQRA review on all applications, but due to the Moratorium on Land Use the Town and Planning Board cannot act on the application and it is a NYS DEC permit that has been applied for. M. Nihan asks why the Town doesn't request that the DEC wait until the Moratorium is over to process the HFA application for C &D. S. Killourhy recommends that question be addressed to the Town Board.

Supervisor Legg states that he asked NYSDEC for a rundown and was informed that this is an incomplete application at this time.

M. Nihan questions why the Town Board isn't the lead agent.

Supervisor Legg states that because of the moratorium, they can't. He adds that he is more comfortable with having the state be the lead agency as they do this every day, the Town Board doesn't have the knowledge or the background.

M. Nihan requests that if a public hearing is held, could it be at the Town Hall instead of in Stamford at the state office.

Supervisor Legg will call NYSDEC and request a local public hearing.

Ray McGinnis states that he was not aware the Town Board was having a workshop on the junkyard law; he feels that this law encompasses a lot of people who are unaware of what the Town Board is doing. He feels that the workshop was not well publicized and would like to see another public hearing held.

Jimmy Meigs states that he does antique car restoration, questions if he would fall under the law.

Supervisor Legg states that this type of business has been addressed in the law.

Councilman Kukle suggests that people attend the land use meetings.

Priscilla Graef asks the board if they have any plans to address the areas in town still without cable, cellular service or internet.

Supervisor Legg states that the town has been requesting that Time Warner put in a generator to allow for cable telephone customers to continue having phone service when the power goes out since Hurricane Irene and the request was denied. He adds that the town can put in a request but the companies can do what they choose. Reggie Bates asks if any changes to the junkyard law since 7/28/15.

Councilman Kukle states no changes since that date.

STONE CARVING

PRIVILEGE OF THE FLOOR:

E. Martocci states the Moratorium expires on Oct. 5th and wonders when the public hearings for the draft laws will be set. S. Killourhy states she is unsure of the exact date of the expiration of the Moratorium/s, however it is the Town Board that would set such public hearings or extension of the Moratoriums.

C. Arleo asks what the status is of the Haines Fall Auto application for C & D processing with the NYS DEC and if the Town will have an opportunity to review once the moratoriums are lifted or prior to the issuance of the DEC permit. S. Killourhy states she does not know the status of the application and has not received any recent information from DEC.

NEW BUSINESS:

<u>1) Sachs/ NYS DEC Lot Line Adjustment</u>- Platte Clove – M. Moltoris presenting on behalf of Morris Sachs. S. Killourhy states this first came in front of the Board October of 2014 but at that time there was no signed contract from the State. At this time the contract has been executed and the maps have been prepared by the State. M. Moltoris reviews the submitted lot line map showing the lands that will be donated to NYS DEC (0.724 acres) and the 1.352 acres that will be retained by M. Sachs. All property is located on the south side of Platte Clove Road.

OLD BUSINESS:

<u>2) Onteora Club Tennis /Golf House Site Plan, –</u> Tannersville – R. Baumann of Onteora Club presenting. S. Schneider is recused. S. Killourhy states the Onteora Club went before the Town Board and was approved for a hardship waiver under the Land Use Moratorium. The concern was that the disturbance of connecting the new sewer hookup on the same parcel of land Page 8 of 12

would go over the 3500 sq. ft. threshold described in the moratorium. The Board reviews the following:

-Ackn rcv'd REVISED Site Plan& applicant response to DEP comments/ Board concerns 8/18

-Ackn rcv'd NYCDEP comments dated 9/1

-Ackn rcv'd NYS DOH Lead agency response – no approval responsibilities

Project description: Demolition of an existing 2 story tennis/golf building with a 723 sq. ft. footprint. Construction of a new tennis / golf building with a total conditioned floor area of 1, 962 sq. ft. Part of the new structure is a 2-story tennis house building with a footprint that is exactly the same as the existing building (724 sq. ft.). Part of the new structure is a 1 story 'wing' that includes the golf house (496 sq. ft.) and a bathroom/storage room (223 sq. ft.) that connecting the two structures. The structures are also connected by a ground level open deck (819 sq. ft.) The total area of structure and deck is 3, 365 sq. ft. The applicant has indicated all lighting will be down lighting with some walkway lights. S. Killourhy states this is a SEQR Type I action. The Board reviews and completes part II of the Full EAF taking into consideration the comments from C. Garcia of the NYC DEP and the response comments from project architect B. Donaldson. Mitigation measures are being taken and noted on Site Plan for construction and connection of the sewer. The Board declares/ approves a negative declaration on the project based on the information given by the project architect and engineers. Site Plan APPROVED with CONDITIONS: Prior to getting a building permit all NYC DEP approvals are granted and if the existing septic system of the Tennis house is located and traced then it will be decommissioned properly in accordance with NYC DEP guidelines.

3) Eisler 5Acre Subdivision – Lanesville/Lexington -P. Eisler presenting as property owner.

Project description: Subdivide a current 333 acre parcel into six (6) separate parcels each over five (5) acres. All ingress/egress is from Diamond Notch Road. The lands are within both the Town of Hunter and Town of Lexington. Lot 4 has an existing residence with garage and the Town maintains Diamond Notch Road just up to this residence, which includes lot 4, 5, 6. The road is not maintained for lots 1, 2 and 3.

S. Killourhy states there has been no word from the Town of Lexington regarding the status of SEQR Lead agency or a municipal coordinated review. P. Eisler explains that his surveyor was unable to attend the Lexington Planning Board meeting on August 11th, 2015. S. Killourhy states the action is UNLISTED under SEQR. The Board discusses the Road issue, and reviews with P. Eisler his options of bringing the Diamond Notch Road up to Town Highway standards and perhaps getting the other home owners to share the cost or to or construct a Road Maintenance Agreement (RMA) with other property owners to share maintenance of that portion of the Road.

The Board is unable to move forward with the application without hearing from Lexington or the other agencies; the application is still considered incomplete.
