6:30 PM Public Hearing-CONTINUED from May meeting: hardship waiver - Waverly Corporation Supervisor Legg re-opens the public hearing regarding a hardship waiver for Waverly Corporation under the Site Plan Moratorium.

Larry Marshall (engineer and surveyor for the project) states that Primex is the developer for the project and Dollar General is the tenant. He adds that the parties want to work with the town to come up with a design that is economically feasible and fits in with the surroundings.

Supervisor Legg asks if the developer would pull out if not granted a hardship variance.

- L. Marshall states that Primex won't proceed on a whim and there are substantial financial fines if they miss their deadline for delivering a store to Dollar General.
- D. Kukle asks him to keep in mind that this parcel is on a scenic byway and in the Catskill Park.

Sean Mahoney asks the board to wait until the moratorium expires and the new land use laws take effect.

Discussion regarding whether or not the store can be supported by the population of the town.

Supervisor Legg asks what permits have been issued and adds that any permits issued by a state agency are not in the town's jurisdiction.

Margaret Nihan is concerned that the work being done to the private residence next to the garage will just blend in and become part of the Haines Falls Auto business and asks how this will be monitored.

Christine Arleo states she is unsure.

Supervisor Legg states that any roads would have to be permitted and the receipt of C&D waste involves NYSDEC and the owner of the business would have to meet their guidelines. He adds that he will speak with Officer Dewey, ask what permits have been issued and voice the concerns expressed here tonight.

Minutes of the May 5th, 2015 meeting – approved.

PRIVILEGE OF THE FLOOR – Offered and M. Murin and M. Rossmy request to speak when Cortina Mtn Estates comes up on the agenda.

NEW BUSINESS:

1) Mountain Top Arboretum Site Plan, Sketch Plan – Tannersville – M. Bliss of Kaaterskill Associates and Joan Kutcher presenting. S. Killourhy states that the applicants applied for a hardship variance from the Town Board, a public hearing was held and at the May 16th, 2015 meeting approved the hardship. M. Bliss explains the overall plan for the project which involves 2 Phases. Phase 1 involves the demolition of existing barn and rebuilding of a larger equipment storage building (864 sq. ft.), improvements to the existing road and parking area. Phase 2 involves the construction of a new Visitors Center which would be a 1-story timber framed wood and stone building approximately 2100 sq. ft., with a basement below. The building would consist of 800 sq. ft. multipurpose space, a 500 sq. ft. lobby-portico with another 800 sq. ft. office, kitchenette, meeting room and toilet facilities. The building would open up to the outdoors to allow visitors to flow in and out of the building on their way to visiting the West Meadow and Woodland Walk. S. Killourhy states this is a Type I action under SEQRA due to the proximity to Onteora Park Historic parcels. S. Killourhy states this will be a coordinated review with: NYC DEP, NYS DEC, NYS DOH, Greene County Highway, NYSHPO, and Greene County Highway. The application will also be sent to Greene County Planning for 239 Review. The Board reviews part of the Full EAF prepared by the applicant. The Board points out a few things that need to be amended. The Board votes unanimously to be Lead Agency on the application. The Board also votes unanimously to conduct a public hearing at the July meeting.

OLD BUSINESS:

- 2) Cortina Mtn Estates Site Plan Review and Subdivision Haines Falls- Attorney J. Shaw and D. Baker presenting. Chairman S. Killourhy first discusses with the Board that the approval given in January for Conditional Subdivision Approval of CME was for 180 days and will expire before the next Planning Board meeting. The applicants have requested in writing a 90 day extension for the approval. The Board reviews and discusses the resolution granting a 90 day extension. The Board has questions as to how many times the Conditional Subdivision Approval Resolution could be extended. J. Shaw states that Town Law 276 had been amended and it can be extended the 90 days for as many times as needed. The Board agrees to look at how many conditions have been met after the next expire of this 90 day extension. The Board unanimously votes to approve 90 day extension. (Resolution for 90 day extension, letter requesting extension and original resolution attached) The Board then reviews the Draft Resolution for Site Plan Approval for the Cortina Mountain Estates Subdivision.
- S. Killourhy recognizes M. Rossmy and M. Murin, who requested to speak during privilege of the floor. M. Rossmy states concern regarding the wording of condition #4 regarding the generator at the well. The Board discusses and agrees with applicant to change the verbiage to exactly how it was stated in March of 2010. M. Rossmy and M. Murin both state concern regarding Cortina Valley Road being maintained during and after construction phases. The Board reviews item #1 in the draft resolution and agree to change wording to state "existing home owners". The Board approves the draft with the changes discussed. (unsigned copy attached)
