Joel Friedman with NYCLASS gives presentation.

Investment program only for municipalities, fire and school district. They offer daily liquidity and the rates compound daily. No minimum investment and unlimited sub-accounts. Their holdings include treasury bills, overnight repurchase agreements, letter of credit to the Federal Home Loan Bank. They have been in business for thirty years.

In light of a telephone call from Councilman Mahoney on 3/20 stating that he did not audibly vote Aye and a corresponding email the vote will be recorded as 4 Ayes and 0 Noes. The Town Clerk heard no audible Aye, Nay or Abstention from Councilman Mahoney. As the removal of his Aye does not change the outcome of the vote, it will be recorded as follows.
