Project description: 18- Lot Subdivision of the 201.4-acre parcel located at the intersection of County Rte. 23C and Cranberry Road in Tannersville. The subdivision will include 15-lots that will accommodate construction of singlefamily homes and 3-lots will be not-buildable lots. The new roadway into the subdivision will extend 2,200 ft. from its intersection with Cranberry Road and include a cul-de-sac. Community sewer utilities are also proposed.
