#### PRIVILEGE OF THE FLOOR

Roger Armstrong states that on 8/20 he asked the Code Enforcement Officer for a copy of a complaint form for unsafe buildings as well as a copy of a notice served upon SHW Realty. He adds that later these documents were left for him at the Town Hall back door. He states that he was told SHW was in contract with someone to demolish the building formerly known as Pete's Place as well as the cabins on the property. He feels that these unsafe buildings should be gone. He states that the Town passed an Unsafe Building law in 1981.

Councilman Semenza states that there was a plan in place to take it down.

- R. France states that the owner was given a price, asbestos was discovered so the cost tripled, and he feels this is why the buildings still stand.
- E. Reale states he spoke to the manager of Williams Lumber and was told they were waiting on asbestos abatement and for the contractor to fulfill obligations.
- R. Armstrong informs the board that there are some inaccuracies on the Town's website, specifically John Farrell's term dates and Keith Byrne is still listed as an employee.
