Slutzky Trust regarding the proposed annexation of certain lands into The Village of Hunter identified as Parcel Numbers 164.00-5-2.21, 164.00-5-2.22 and 164.00-5-5.1.

Sarah Schneider states she is representing 776 Hunter Realty and the Paul Slutzky Trust. They are applying to annex three parcels into the Village of Hunter so the parcels can have access to municipal water and sewer. The parcels total forty-two acres of developable land and she feels it is in the best interest of both municipalities to allow this to proceed.

A member of the public asks how many houses will be built and if there has been a study done on the feasibility of water hookups.
