Councilman Kukle offers RESOLUTION #9 of 2022 Authorizing a Real Property Tax Exemption and the Execution of a Payment In Lieu of Tax (PILOT) Agreement by and Among the Town of Hunter, New York, Cold Spring Housing Development Fund Company, Inc., and Cold Spring Limited Partnership. Seconded by Councilman Semenza.

RESOLUTION OF THE TOWN BOARD OF THE TOWN OF HUNTER AUTHORIZING A REAL PROPERTY TAX EXEMPTION AND THE EXECUTION OF A PAYMENT IN LIEU OF TAX ("PILOT") AGREEMENT BY AND AMONG THE TOWN OF HUNTER, NEW YORK, COLD SPRING HOUSING DEVELOPMENT FUND COMPANY, INC., AND COLD SPRING LIMITED PARTNERSHIP

WHEREAS, the Town of Hunter (the "Town") desires to encourage the development of affordable housing that is safe and sanitary; and

WHEREAS, RUPCO, Inc., a not-for-profit developer of low and moderate income housing ("RUPCO") has identified property owned by the Village of Tannersville located at 55 Spruce Street, in the Village of Tannersville, Town of Hunter, Greene County, New York, Section 182.09, Block 1, Lot 18 on the tax map of the Town (the "Land"), <u>for the purpose of contructing on the Land a housing project for persons of low and middle income, said project to consist of: (i) the acquisition of the Land; (ii) demolition of existing structures on the Land; (iii) construction thereon of fifty-six (56) units of housing for persons of low and middle income, including one superintendent's unit, and related improvements to be known as Cold Spring (the "Improvements"); and (iv) the acquisition and installation therein and thereon of certain machinery, equipment, furniture, fixtures and other tangible personal property (the "Equipment"). The Land, Improvements and Equipment are collectively referred to in this resolution as the "Project"; and</u>

WHEREAS, in order to own and develop the Project, RUPCO plans to form two new entities to be known as (i) Cold Spring Housing Development Fund Company, Inc., an Article XI New York Private Housing Finance Law corporation and a New York not-for-profit corporation (the "HDFC"), and (ii) Cold Spring Limited Partnership, a New York limited partnership (the "Partnership") in which the HDFC will be the general partner; and

WHEREAS, the HDFC and the Partnership will be formed for the purpose of providing residential rental accommodations for persons of low and middle income; and

<u>WHEREAS</u>, the HDFC will acquire fee title to the Land, as nominee for the Partnership, and will convey its equitable and beneficial interests in the Land to the Partnership in furtherance of the development of the Project; and

WHEREAS, the HDFC's and the Partnership's plan for the use of the Land constitutes a "housing project" as that term is defined in the Private Housing Finance Law of the State of New York ("PHFL"); and WHEREAS, the HDFC will be a "housing development fund company" as the term is defined in Section 572 of the PHFL and Section 577 of the PHFL authorizes the Town Board to exempt the Project from real property taxes and agree to a payment-in-lieu-of-taxes agreement with the HDFC and Partnership ("PILOT Agreement"); and

<u>WHEREAS</u>, the Partnership and the HDFC are willing to enter into a PILOT Agreement whereby they will make annual payments in lieu of taxes to the Town as set forth in the PILOT Agreement substantially in the form as presented to the Town Board for approval, a copy of which is attached;

NOW THEREFORE, BE IT RESOLVED that the Town Board hereby:

- (i) exempts the Project from all real property taxes to the extent authorized by Section 577 of the PHFL for a period of thirty (30) years; and
- (ii) approves the PILOT Agreement by and among the Town of Hunter, the Partnership and the HDFC, substantially in the form attached as Exhibit A, providing for annual payments as set forth in such PILOT Agreement; and it is

FURTHER RESOLVED, that the Town Supervisor of the Town of Hunter is authorized to execute and deliver the foregoing PILOT Agreement on behalf of the Town; and it is

FURTHER RESOLVED, that this resolution shall take effect immediately.
