G. Lubow speaking on behalf of Guy Chirico asks the Town Board not to allow the annexation based on the water system, permits and his belief that the property is not part of the water district which should disqualify this for annexation at this time.

Hyde Clark – Attorney with Young & Sommer representing the applicant states there are no changes proposed at this time but if annexed they would pursue connection of the sewer line.

Discussion on the mention of accessory camping and that additional site plan approval would be needed.

M. Chodok states that there is no tent camping or additional camping outside of the structures.

G. Lubow states he does not see how a Certificate of Occupancy can be issued until a sewer line is in place and there is no water at this time.

M. Czermerys states the application has been approved based on having a septic system and a condition on the approval that they need to improve the Whistle Tree water system to the point that it would not negatively impact other people on the same water system. He adds that those were the conditions and that was how it was approved. He states if they move this not the village, they have to get approval from the village for site plan revision to allow it to connect to the sewer because that is a change in site plan. They are still under the condition that the water has to be dealt with. They can't get a Certificate of Occupancy unless they deal with the water.

Andy of Taghkanic Engineering states that it is always a public benefit to connect to an existing sewer system than to discharge into the ground. Once they made that decision, that is why they are here because they need to annex into the village in order to be able to connect, abandon the onsite wastewater system, still making Whistle Tree improvements, but the onsite system goes away because they would be coming into the village to make that connection.
