PUBLIC HEARINGS

<u>Hunter Foundation Philadelphia Rd Church Site plan, Parcel #181.16-3-6</u> Elka Park

- -Richard Brooks Presenting
- -Site Plan has been revised per recommendations from the board
- -1 ADA parking spot moved towards the front of the church
- -The staging area for the catering truck has been moved.
- -Bathrooms have been moved over to the side of the building
- -Expanded the parking lot one more spot.
- -Parking for ADA spot will be paved.
- -Matthew Hunter would like to know how many light fixtures and how high will they be.
- -Mr Brooks said they are 12 feet high.
- -Suzanne Hunter would like to know which direction the lights will be facing.
- -Mr Brooks said they will not be able to see the lights from the property
- -Mr Mahoney said the lights will not be on when the church is not in use.
- -Suzanne Hunter would like to know what kind of events are going to be held at the church.
- -Mr Mahoney said that small music events, recording artist and community gatherings.
- -Suzanne Hunter wanted to know what are the hours going to be.
- -Mr Mahoney states that 99% of the time the event will be done by 11pm
- -Mr Czermerys states that there is a law that requires quite hour starts at 10pm. The owner will have to comply with this law.
- -The events will be indoors and seasonal.
- -The parking will be on the corner of Bloomer Rd and Platte Clove Rd.
- -Matthew Hunter wanted to let everyone know someone might come across with graves not marked.
- -The ramp will be in the back door and will be attached to the church.
- -Nick Tinari did not have time to review it.

- -Marc Czermerys states that all the updates came in this afternoon.
- -Mr Tinari wants to know if things were moved on the site plan.
- -Mr Tinari wants to make sure there is a lumin level and states it's required.
- -Mr Brooks said he could submit a form.
- -Suzanne Hunter couldn't find the meeting information on the website. Marc Czermerys explained where to find it.
